You can enable/disable rules from project settings page. Just go to the debt configuration section included with the plugin:

This rule checks if issue timespent is over estimation

This rule checks if issue description is too short

This rule checks if issue is not estimated

This rule checks if issue is not assigned

This rule checks if issue estimation is too long

This rule checks if issue is taking to much time
